Promotional Release Waiver

Insurance

It is the responsibility of every individual, their parent or legal guardian, to provide for their own accident and health coverage while participating in all Merrimack Valley YMCA Family Camp activities. The Merrimack Valley YMCA is not responsible for any items lost on the premises.

Termination/Refunds/Cancellations

The Merrimack Valley YMCA Family Camp reserves the right to terminate a family's participation at Family Camp (at the expense of the family) if it is in the best interest of the camp. A \$200 deposit per family is required during the reservation process and is **non-refundable and non-transferable** unless cancellation is due to a death in the family or a certifiable illness. The cabin rate is due in full by August 1, 2021. The remaining balance of the Family Camp fees is due upon the completion of a family's stay and before they depart from the camp grounds. All cancellations must be made prior to August 1, 2021 in order for a family to not be responsible for the fees associated with their family's stay; an exception to this policy will be made if we are able to fill your family's space.
